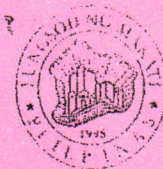

### BARANGAY EXECUTIVE ORDER

No.001/ Series of 2020

#### PREVENTIVE MEASURES AND GUIDELINES DUE TO RISKS POSED BY CORONA VIRUS DISEASE (COVID19) AND CREATION AND COMPOSITION OF THE TASK FORCE FOR THE MANAGEMENT OF COVID-19

**WHEREAS**, on March 9, 2020, the Philippines declared the rapid spread of the Novel Corona Virus Disease (COVID-19) as a public health emergency;

**WHEREAS**, on March 11, 2020, the World Health Organization has characterized the spread of the disease as a pandemic as it continues to spread throughout the world;

**WHEREAS**, as of March 14, 2020, 156,433 people have been infected and 5,821 have died of COVID-19;

**WHEREAS**, on March 12, 2020, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases of the National Government issued Joint Resolution No. 11 for the management of the COVID-19, providing for strict social distancing guidelines, including suspension of classes, prohibition on mass gatherings, community quarantine, and restriction of domestic and international travel;

**WHEREAS**, in compliance with the Inter Agency Task Force for the Management Of Emerging Infectious Disease Resolution No. 11 and the Department of Interior and Local Government directive under Memo Circular 2020-018 that cities and local government units (LGU's) need to pass or amend their own curfew ordinances in accordance with updated guidelines from the Office of the President;

**WHEREAS**, the City of Makati has issued Executive Order No. 10 to prevent, control, and manage COVID-19;

**WHEREAS**, despite these interventions, the disease continues to spread rapidly;

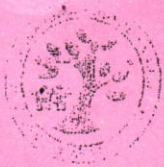
**WHEREAS**, Barangay Dasmariñas recognizes that COVID-19 is a public health emergency with wide-ranging social, political, and economic repercussions, and that responding to the barangay's COVID-19 situation is imbued with public interest;

**NOW THEREFORE, I, ROSSANA Y. HWANG**, Punong Barangay of Barangay Dasmariñas, City of Makati, by virtue of the powers vested in me by law, do hereby order the adoption, coordination, and implementation of the following Protocols and Guidelines to ensure the health and safety of our constituents of Barangay Dasmariñas, to wit:

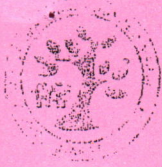

## SECTION 1. ENHANCED COMMUNITY QUARANTINE FOR BARANGAY DASMARIÑAS.

1. Strict home quarantine shall be observed in all households with movements limited to accessing basic necessities.
2. As a general policy, everybody in the Barangay is directed to restrict their movements and remain in their residences, especially persons who are at high risk of being infected by COVID-19, i.e.:
  - a. Those sixty (60) years old and above;
  - b. Those who are immunocompromised or with co-morbidities; and
  - c. Pregnant women.
3. To further promote social distancing, the following establishments shall be closed, to wit:
  - a. Gyms, basketball courts, badminton courts and other similar establishments;
  - b. Schools;
  - c. Restaurants and or food stalls, except for takeout or deliveries; and
  - d. Business Establishments providing non-essential services.
4. In compliance with the Enhanced Community Quarantine by the National Government, only one person per household would be allowed to buy/access basic necessities.
5. The Barangay Hall shall remain open and will operate with a skeletal force to continue to deliver vital and essential services to Barangay Dasmariñas. Access to the Barangay Hall for the people's concern shall be limited and controlled to enforce social distancing and protect all from transmission of COVID-19.
6. Where strict home quarantine shall be implemented, transport shall be suspended and provision for food and essential health services shall be regulated for persons positive with COVID-19, a Person Under Investigation (PUI) or a Person Under Monitoring (PUM), subject to other recommendations from the City Government of Makati and the National Government, including the Inter-Agency Task Force for the Management of Emerging Infectious Diseases of the National Government. If a person positive with COVID-19, is a resident of the Barangay, the Barangay may place the entire house under Enhanced Community Quarantine effective immediately from notice, subject to other recommendations from the City Government of Makati and the National Government, including the Inter-Agency Task Force for the Management of Emerging Infectious Diseases of the National Government.
7. A restriction on visitors of non-residents or non-essential persons shall be imposed.
8. A suspension of all construction activities and entry of construction workers, contractors, and deliveries that are not essential is hereby imposed.
9. A curfew from 8:00pm to 5:00am shall be implemented in Barangay Dasmariñas from March 19, 2020 to April 14, 2020 unless extended or shortened upon the recommendation of the City Government of Makati and the National Government, including the Inter-Agency Task Force for the Management of Emerging Infectious Diseases of the National Government. Exempted from the curfew are:

- a. Those working in businesses allowed to operate by the City Government of Makati and the Inter-Agency Task Force for the Management of Emerging Infectious Diseases of the National Government ;
- b. Health workers;
- c. Authorized government officials;
- d. Those traveling for humanitarian or medical reasons;
- e. Persons providing basic services and public utilities;
- f. Persons delivering food and medicines; and
- g. Essential skeletal workforce of Barangay Dasmariñas.

Minors shall not be allowed to leave their residences except for medical emergencies or humanitarian reasons.

10. The Barangay Officials and Barangay Tanods, together with the members of the Philippine National Police and other uniformed personnel are directed to strictly enforce this Executive Order.
11. Installation of checkpoints around the Barangay will be imposed for the purpose of enforcing the enhanced community quarantine.
12. No person may exit their residence without any of the following:
  - a. Valid government Identification Card;
  - b. Proof of residence;
  - c. Certification of Employment;
  - d. Delivery Receipt for those transporting goods to and from the area;
  - e. If applicable, authorization issued by the Government.
13. Members of the LGU of Barangay Dasmariñas shall coordinate and work together with the Dasmariñas Village Association on the abovementioned matters.

## SECTION 2. IMPLEMENTATION OF STRINGENT SOCIAL DISTANCING MEASURES

### A. Residential Communities

1. Residents will be required to:
  - a. Stay home;
  - b. Curtail activities and social gatherings;
  - c. Limit the home deliveries to essential items like food, groceries, medicines, medical supplies, and other essential house hold materials. Non - essentials deliveries are restricted; and
  - d. Limit visitors to health workers, persons providing basic services for food or utilities in accordance with updated regulations by the Inter-Agency Task Force.
    - i. If the visitor has fever of more than 37.5 degrees Centigrade, the concerned resident or employer will be informed of the situation and the visitor will not be allowed entry
2. If a resident of Barangay Dasmariñas or any person who is within the territorial jurisdiction of the Barangay is exhibiting any symptoms related to COVID-19, they will be required to inform the Barangay, via telephone, cellphone, or internet communication, of their name, address, contact details, travel history within and outside of the barangay and their symptoms.


## SECTION 3. IMPLEMENTATION OF THE FOLLOWING PROTOCOLS TO EFFECTIVELY MONITOR COVID19 IN ACCORDANCE WITH RA 11332.

REPORT	TO	FOR
Persons with symptoms of: Runny/stuffy nose and/or sneezing, with no known contact or exposure.	No need to report	Practice social distancing, stay home and rest.
Persons with symptoms of: Fever, cough, muscle ache, fatigue, headache, and/or sore throat but with no history of exposure (PUM).	Barangay Clinic: 88172105  Barangay Emergency Line: 88123335 loc.101	For monitoring of strict compliance with 14-day self-quarantine.
Persons within the community who travelled from counties affected by COVID 19 (PUM).	Barangay Clinic: 88172105  Barangay Emergency Line: 88123335 loc.101	For monitoring of strict compliance with 14-day self-quarantine.
Persons within the community who display the following symptoms: Fever, cough, shortness of breath, diarrhea AND history of exposure (travelled to countries affected, close contact of COVID 19 patient, works in healthcare facility with COVID-19 patients (PUI)	MAKATI COMMAND CONTROL & COMMUNICATION CENTER - 168	For referral to health facility for testing. (PUI)
Persons with confirmed COVID-19 who entered or are within the Barangay.	MAKATI COMMAND CONTROL & COMMUNICATION CENTER - 168	For referral to a health facility.  The area would be for disinfection and close monitoring.

## SECTION 5. QUARANTINE OF STREETS

In case there are two or more PUI or COVID-19 positive cases in the same street, the whole street shall be placed on quarantine. No person shall be allowed to enter or exit the street, until it is deemed clear by Makati Health Department.
